- Applicants must submit a 2022 completed ECCV rebate application and all required documents within 1 year of purchase date.
- Rebates are available to the customer listed on the ECCV water bill. Account balance must be current.
- The rain sensor must be installed at a residence located within the District water service area.
- Site may be subject to inspection by District staff, which will be scheduled prior to rebate being applied to the account.
- Only pre-existing homes are eligible for the rebate. This program is not available to new construction.
- Your ECCV account will be credited for the rebate. *Rebates will not be paid in cash or by check. Please allow 4-6 weeks for processing.*
- Make a copy of the application and receipt for your records.
- **Please do NOT mail your application with your payment.**
