- Applicants must submit a 2019 completed ECCV rebate application and all required documents within 1 year of purchase date.
- Rebates are available to the customer listed on the ECCV water bill. **Account balance must be current.**
- Rebate offer allows for a maximum of two toilets per ECCV account.
- Homes built **before 1994** qualify for \$100 rebate
- Homes built **after 1994** qualify for \$50 rebate
- Replacement of old toilet with same gallons per flush as new toilet do not qualify. The new toilet **MUST** be less gallons per flush.
- Each new ultra low-flow toilet must be listed on the current EPA WaterSense Approved Toilet list issued by ECCV.
- Dual flush toilets must have a maximum flush of 1.1 gallons per flush on both flush buttons.
- Please allow 4 to 6 weeks for your rebate to be processed.
- Your ECCV account will be credited for the rebate(s). *Rebates will not be paid in cash or by check.*
- Make a copy of the application and receipt for your records.
- **Please do NOT mail your application with your payment.**
